LICENSE RENEWAL FOR THE LICENSE YEAR 7/1/2024 – 6/30/2025

This is your license renewal application and serves as notice that your Kansas Veterinary License will expire on June 30, 2024.

There are two ways to renew your veterinary license:

2. Complete this form with signature and return to the KBVE office, along with your payment of **\$100.00**, no later than **June 30, 2024**.

Veterinary licenses not renewed online or postmarked by June 30, 2024, have 60 days to renew and will be charged an additional \$100.00 late renewal penalty. If not renewed in the 60 days, the license will expire, and you will have to reapply with a new application.
